- 2020 Show Dates: The North Dakota Winter Show Dates will be March 3<sup>rd</sup>-8<sup>th</sup>.
- Snow Insurance: Kelcey Hoffmann presented the snow insurance policy to the board for the 2019 show. Discussion was had and we will reach out to other companies to see what can be offered. This will be tabled until the next meeting.

## Committee Reports:

- Arena/Grounds: The board was presented with amount owed on the completion of the building and doors for \$57,100. The employees and directors will make a list of issues that need to be completed. Dave Zubrod presented the opportunity to have the door skirting done on the South Exhibit Building at the cost for \$500 to the NDWS. The heater in the north washrack is beyond repair. Kelcey Hoffmann will reach out to Baakegard to get an estimate on replacing the heater for north and south wash rack. Dan Donnelly gave the board an update on the letter received regarding the drainage ditch. Handicap doors will need to be installed in the new building. Royce Kinney will

- Rodeo/Ranch Rodeo: Discussion was had on the new center out process for the PRCA Rodeo. Concerns were raised regarding the added expense for the panels and getting the crows nest to fit. Directors agreed to proceed with the center out format at no expense to the NDWS. Ranch Rodeo will be held on Thursday, March 7<sup>th</sup> at 6:30pm. Kelcey Hoffmann will reach out to Bailey Pro Rodeo and Howard Larson for bids that will be presented at our next meeting.
- Rodeo Queen: We have started searching for candidates.
- Concert: Update was given on the concert. The building will be closed from 5:00-5:30pm on Friday, March 8<sup>th</sup> to clear the building for the concert and when it reopens every individual that enters the building must present a ticket. No re-entry will be allowed, and we will have an area for smoking. The arena will open at 6:00pm for concert go-ers to enter. The VIP party will be held in the South Exhibit Building from 5:30-6:30pm. There will be an area fenced off. Discussion was had on having hard liquor served in the pub and the beer gardens.
- Crop Show: Crop Show booklet is being finalized and will be sent off to the printers.
  Randy and Anthony will begin work on the framework shortly.
- Horse: Horse Pull individuals would like to see an increase in premiums. If we see an increase in sponsors, premiums will be increased.
- Livestock: Letters have been sent out to Classic Steer Show, Hog Show, and Junior Cattle Show contestants.
- Hall of Fame: Update was provided by Tim on the Kiosk.
- SEB; Home-Play-Getaway & Ag Challenge: Speaker ideas were thrown around for the week of the annual show.
- Timeless Traditions: Coffee and Donuts will be provided to vendors.
