# Minutes – December 13, 2018

Meeting called to order by Chairman Mike Schwehr

Motion by Carlblom, 2<sup>nd</sup> by Behm to approve November 8, 2018 minutes. Motion carried.

Meeting recessed for the Hearing for Lance Peltier for Rezone to Recreational & CUP for Campground, Lot 3 Blk 2 Jewetts Beach 2<sup>nd</sup> Sub. There was ten letters from property owners in the area against the proposed project. Dick Gulmon was present to speak about his opposition to the project. Lance Peltier was present to explain what his plans are with this project. Campers would be left there year round so he doesn't believe it would cause much more traffic then there is now. Wayne Keller was present to explain his opposition to this project. Sonia Grieger, Dan Klein, Mike Schell, & Mandy Jewett all spoke about there opposition. All of these land owners had about the same opinions about this that they are worried about the traffic increasing and wrecking the road since it is taken care of by the property owners and not the county who would fix the road with any extra traffic, also where would these people access the lake there is no lake access at the proposed area. John Froelich was present and stated that is doesn't believe that this area would be the right spot for this campground. No one else appeared to protest. Chrman Schwehr reopened the meeting for discussion. Schwehr stated that we have been trying to get the lake properties to be on the same rules and this would be spot zoning which is something we do not want to do. Motion by Legge, 2<sup>nd</sup> by Bopp to Deny the Rezone to Recreational and Conditional Use Permit for Campground. Motion carried.
