Meeting called to order by Chairman Mike Schwehr

Motion by Carlblom, 2<sup>nd</sup> by Olauson to approve May 14, 2020 minutes. Motion carried.

Meeting recessed for the Hearing for Kerry Olson for a Variance of 115' from the center of township road 33<sup>rd</sup> St SE. Kerry & Annette were in attendance on the phone to answer any questions about the project. No one appeared to protest. Chrman Schwehr reopened the meeting for discussion. Motion by Erickson, 2<sup>nd</sup> by Behm, to approve the Variance of 115' from the center of township road 33<sup>rd</sup> St SE. Motion carried upon roll call vote, with all members voting "yes".

Mr. Eichten was present on the phone for any questions, he stated the property owners to the North had no issues with this. Jenrich wanted to get input from the board about Alex Bitz's garage. He got a variance back in 2014 which was from property lines. He never built the garage then and now has the garage which is smaller then the one he was going to put up in 2014, he now thinks he may need a Variance from the access roads, and the board decided that yes he would need to acquire a variance. It will be brought to the July meeting.
