Meeting called to order by Chairman Mike Schwehr

Motion by Behm, 2nd by Olauson to approve the February 11, 2021 minutes. Motion carried.

Meeting recessed for Dickey Rural Telephone Cooperative for a Utility Variance of 30' from the center of 51st St SE (Co Rd 38), 133rd Ave SE(Cass County highway 1) & 36th St SE.
