

Technician Report: Jason reported that we have over 94,000 foot of trees planned and he is not taking any more orders for this year. He has spoken to the Nurseries. Lincoln Oakes trees are ready to pick up but Towner Nursery is no and won't be lifting trees until the week of April 23rd. Weed barrier will be delivered to the shed the week of the 23rd. Jason has had 4 applicants for the part time laborer position but is still looking for a Tractor Driver. OHF applications for 2019 tree planting season are now open until the end of July. Jason has a list of producers that he will be contacting.

OLD BUSINESS:

- 1. Jill submitted the Grant Application for Operation Round Up. This grant is offered through Cass County Electric Cooperative Foundation for assistance in providing educational information in your county. For Barnes County, is was specified for Eco Ed Youth Education. Jill will be representing Barnes Co. in June at the Foundation board meeting.
- 2. The Area II meeting was held in Finley ND at the Legion. It was very well attended. Jill handed out A Soil Conservation Timeline power point so everyone could review.

NEW BUSINESS:

- 1. The board received a request of monies pledged to the ND Envirothon. Stenson made a motion to pledge \$1,000 to the Envirothon with Paulson seconding the motions. All in favor aye, motion carried. Jill will complete the pledge form and mail with a check to Dane Busse.
- 2. The board reviewed the email sent by Jim Collins regarding the use of the Tech Grant funds and a possible Watershed Management Program grant to rent 20 acres of land from a producer for a demonstration learning plot. The board and the staff had some additional questions for Jim. Jill will email and report next month.

Red River Basin Initiative (RRBI): Sign up deadline May 18th, 2018

- Red River Basin Watershed Map- only land on that map is eligible in Barnes Co.

CSP: 2018 Sign up ended on March 2nd.

- We have three applications
 - Have worked through most of the paperwork with one producer
 - Applications need to be ranked by April 27th, 2018
- o 2019-1 CSP Renewals
 - 4 contracts up for renewal.
 - Renewal sign up is this Friday 4/13/18.

CRP: No new information.

WRE:

- No WRE Contracts funded in Barnes County for 2018.
 - o Only 1 was funded in Area 2 (per Area Biologist).
 - o Barnes County had 9 applications
- 21 Offsite and Ownership Annual Monitoring Review worksheets have been completed ahead of the deadline (4/13/18).
 - o 12 On-site annual monitoring reviews will need to be completed once we get the list and the snow melts.

 - Any species that are salt tolerant.
