

Minutes of Meeting February 9th, 2022 USDA Building Valley City, ND 58072

#### FINANCIALS:

Technician Report: Jason reported that Feb. 15<sup>th</sup> is the deadline for tree ordering. We have 17 sites planned for this spring with about 70,000 trees. He has ordered the majority of his trees from Big Sioux in South Dakota, then most of the rest from Towner State Nursery and very little with Lincoln Oakes. He had Twin City Garage Door out to fix the shed door. Jason will be advertising for seasonal help once again. He would like to raise the pay to \$14 per hour for workers and \$15 for tractor drivers. Stenson make a motion to support the pay increase, D. Olson second the motion. All in favor aye, motion carried. Jason has 6 sites lined up for the grass seeder with the tree plantings.

Alex and I have been working with the two 2020 WRE's that were approved for funding

Shawn has been working with FSA to complete cost share practices for CRP

PPWQWP is going to have another funding round. Currently our office has several(8) different contracts through this funding

Cody has been working on CRP's for the four counties and helping LaMoure with EQIP

Valley City office will be getting a summer intern employee (Pathways Trainee)

NRCS is expecting supervisors to return to physical workplace April 18<sup>th</sup> and nonsupervisory employees May 2<sup>nd</sup>
