

The Barnes County Commission met in regular session Tuesday, February 5, 2008, with all members present.

Kerry Johnson, Highway Superintendent, presented a letter approving the 4th St. Bridge project completion.

Commissioner Berntson made a motion, seconded by Triebold, to approve and sign the acceptance letter for the 4th St. Bridge project. Motion carried.

Mr. Johnson also discussed a schedule of motor graders and vehicles owned or leased by the County, and the possibility of a new motor grader purchase in 2008.

The Commission directed Johnson send a letter to the State Highway Patrol requesting assistance for load restrictions for the year.

Kim Franklin, Emergency Manager, met with the Commission to request approximately \$650.00 to print emergency guide booklets for elementary students. The Commission requested that Ms. Franklin also seek alternative funding sources to help pay for the booklets.

Commissioner Triebold made a motion, seconded by Weber, to allow Franklin to publish the booklets and to amend the Emergency Management budget to include a publishing line item for \$1,500.00. Upon a roll call vote with all members voting "yes," motion carried.

Commissioner Weber made a motion, seconded by Triebold, to approve the January 22 minutes with corrections. Motion carried.

Commissioner Berntson made a motion, seconded by Opdahl, to approve a raffle permit for the Green School Community Center. Upon a roll call vote with all members voting "yes," motion carried.

Jason Thiel, MIS Director, met with the Commission at their request to discuss Internet monitoring software.

Commissioner Opdahl made a motion, seconded by Triebold, to approve the purchase of Web Sense Express software, at a cost of approximately \$3,800.00. Upon a roll call vote with all members voting "yes," motion carried.
