

The Barnes County Commission met in regular session Tuesday, June 2, 2009, with all members present.

Kerry Johnson, Highway Superintendent, and Paul Fuhrer of Keystone Pipeline discussed damages to County Road 27, which was off limits as a haul road to Keystone during their construction period. Mr. Fuhrer apologized to the County for damages and offered a settlement of \$350,000.00 for repairs.

Commissioner Schwehr made a motion, seconded by Froelich, to sign the Release of Damage Claims agreement with Keystone Pipeline, to accept the \$350,000.00 settlement for damages to County Road 27. Upon a roll call vote with all voting "yes," motion carried.

Discussion was held concerning upcoming county road bid letting, to be held in Bismarck on June 5.

Mr. Johnson discussed flood-related emergency road repairs needed.

Johnson also requested to hire an employee to replace an employee who retired last fall.

Commissioner Opdahl made a motion, seconded by Weber, to allow Johnson to hire an Equipment Operator II, at a starting salary of \$11.09 per hour, to fill one open position. Upon a roll call vote with all voting "yes," motion carried.

Discussion took place regarding the effect of the second wind farm project on county roads.

Johnson informed the Commission that road restrictions were lifted as of June 1.

Commissioner Weber made a motion, seconded by Opdahl, to approve the minutes of May 14, 19, 22, and 27, as presented. Upon a roll call vote with all voting "yes," motion carried.

Commissioner Schwehr made a motion, seconded by Froelich, to regretfully accept the resignation of Donelda Remmick effective July 1, after 41 years of dedicated service to Barnes County. Upon a roll call vote with all voting "yes," motion carried.

Commissioner Schwehr made a motion, seconded by Weber, to approve a gaming site authorization for Knights of Columbus #1883 for City Lights and A&J's Lodge. Upon a roll call vote with all voting "yes," motion carried.

Commissioner Froelich made a motion, seconded by Schwehr, to allow the Valley Quilters to use the Courthouse and grounds for the Americana Festival quilt show and craft fair on August 1. Upon a roll call vote with all voting "yes," motion carried.

Brad Cruff, States Attorney, explained a quiet title action for which a summons and complaint was served upon Barnes County.

Commissioner Opdahl made a motion, seconded by Froelich, to approve an Event Alcoholic Beverage Permit for A&J's Lodge for a Red Knights motorcycle club gathering to be held June 11. Upon a roll call vote with all voting "yes," motion carried.

Betty Koslofsky, Tax Director, presented a 2008 tax abatement application from Nathan and Marsha Saylor, for PCL: 20-1020207, asking for a reduction in valuation from \$267,200.00 to \$213,000.00. The recommendation of the Marsh Township Board was a reduction of \$12,000 to the structure. The recommendation of Ms. Koslofsky was to deny the request.

Commissioner Froelich made a motion, seconded by Opdahl, to lower the valuation of PCL: 20-1020207, from \$267,200.00 to \$255,000.00. Upon a roll call vote with Froelich and Opdahl voting "yes," and Schwehr, Berntson, and Weber voting "no," motion failed.

Commissioner Schwehr made a motion, seconded by Weber, to deny abatement on PCL: 20-1020207, as recommended by Koslofsky. Upon a roll call vote with Schwehr, Berntson, and Weber voting "yes," and Froelich and Opdahl voting "no," motion carried.

Ms. Koslofsky presented an additional abatement request from Nathan and Marsha Saylor for PCL: 20-1020208, asking for a reduction in valuation from \$24,900.00 to \$13,000. The Marsh Township Board recommended the request be denied. Koslofsky recommended denial of the request.

Commissioner Froelich made a motion, seconded by Opdahl, to deny the abatement on PCL: 20-1020208. Upon a roll call vote with all voting "yes," motion carried.

Kim Franklin, Emergency Manager, and Colette Baum-Meister, FEMA, met with the Commission to update them on application numbers. Ms. Baum-Meister, provided the following numbers: state applications – 5,332; Barnes County visits – 1,487; and Barnes County applications – 987; and total dollars approved for county residents - \$444,719.00.

Ms. Franklin discussed options for what to do with the clay and sandbags from the Woodland Park dike.

Commissioner Froelich made a motion, seconded by Weber, to proceed with emptying all the sandbags at the Winter Show location. Upon a roll call vote with all voting "yes," motion carried.

Franklin also discussed her volunteer work with the Barnes County Ambulance Service.

Commissioner Froelich made a motion, seconded by Opdahl, to allow Ms. Franklin to volunteer for the ambulance starting July 1. Upon a roll call vote with all voting "yes," motion carried.

Discussion was held concerning whether Franklin could work the Highway Department's summer hours (four days, 10 hours each).

Commissioner Froelich made a motion, seconded by Opdahl, that Ms. Franklin may follow the summer Highway Department hours of four 10-hour days, as long as her office is in the Highway Department building. Upon a roll call vote with all voting "yes," except Schwehr, voting "no," motion carried.

The Commission thanked Franklin for her long hours and hard work during the flood emergency.

Richard Betting and Archie Moore, representing the People to Save the Sheyenne, discussed their concerns about Devils Lake drainage into the Sheyenne River.

Gene Bjerke, Sheriff, met with the Commission to discuss corrections staff. One correctional officer has resigned, and the part-time cook will retire soon.

Commissioner Weber made a motion, seconded by Opdahl, to have the Sheriff's Office do the striping and letter on the used Tahoe. Upon a roll call vote with all voting "yes," motion carried.

Katie Hajicek, Family Nutrition Program coordinator, updated the Commission on the Extension's nutrition program and requested that Chairman Berntson sign the service acknowledgement form.

Commissioner Schwehr made a motion, seconded by Froelich, to have the chairman sign the Acknowledgement form as presented. Upon a roll call vote with all voting "yes," motion carried.

The Commission discussed the Compensation Committee's 2010 salary recommendations.

Commissioner Weber made a motion, seconded by Froelich, to re-appoint Liz Johnson to another 3-year term on the Library Board. Upon a roll call vote with all voting "yes," motion carried.

Commissioner Schwehr made a motion, seconded by Opdahl, to re-appoint Dr. Gerald Norberg and Jack Formo to another 3-year term each on the School Annexation, Reorganization, and Dissolution Board.

Commissioner Froelich made a motion, seconded by Weber, to re-appoint George (Tom) Overn and Dale Maasjo to another 3- year term each on the Social Services Board. Upon a roll call vote with all voting "yes," motion carried.
