The Barnes County Commission met in regular session on Tuesday, August 7, 2018 with Cindy Schwehr, Mike Metcalf, Bill Carlblom, John Froelich, and Rodger Berntson present. Chairman Carlblom called the meeting to order at 8:00 a.m., the Pledge of Allegiance was recited, and the Agenda was reviewed.

Treasurer – Cancel Outstanding Checks

Vicki Zinck-Metcalf, Treasurer, presented a list of checks to be cancelled, per North Dakota Century Code §11-25-05: Check #5038 dated 9/9/2016 payable to Cornerstone Bank in the amount of \$10.00; Check #132037 dated 5/3/2016 payable to Laurie Hatcher in the amount of \$20.00; Check #133480 dated 10/5/2016 payable to Jennifer M Moss in the amount of \$68.00; and Check #135569 dated 4/4/2017 payable to Mark Klabo in the amount of \$25.54. Mike Metcalf moved to cancel the checks; Cindy Schwehr seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". If the party entitled to any such warrant shall appear and give good and sufficient reason for the party's delay in calling for such warrant or in presenting the same for payment, the board may issue a new warrant in the amount to which the party is entitled, except for the statute of limitations.

Bid Opening - Surplus Highway Vehicles

Kerry Johnson, Highway Superintendent, opened bids for the surplus highway vehicles. High bids were as follows: Kevin Eberle - \$1,250 for the 1993 GMC Crew Cab; Gille Auto - \$1,802 for the 2002 F450 Cab/Chassis; and Gille Auto - \$808 for the 1985 Dodge 2 door pickup. Cindy Schwehr moved to accept the high bids; Mike Metcalf seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".

<u>Highway Dept – Uxbridge Road Discussion</u>

John Froelich updated the Commission on discussion with Uxbridge Township/Stutsman County officials regarding possibly making 3 ½ miles of township road in Barnes County (1 ½ miles) and Stutsman County (2 miles) an "improved gravel road", to take some pressure off the Urbana road. Kerry Johnson followed up with possible costs of about \$60,000, as well as pros and cons.

Sheriff - Portable Radios & In-Car Repeaters / Home Monitoring / Part-time Employees

Randy McClaflin, Sheriff, requested approval to trade in two car repeaters for new ones at a total cost of \$2,520 to upgrade. Mike Metcalf moved to approve the request; Cindy Schwehr seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". Grant funding will be pursued for additional car repeaters and portable radios. John Froelich moved to purchase one portable radio at a cost of \$6,263.70; Cindy Schwehr seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". Corrections will have four open full-time positions, and it's difficult to hire part-timers for under 20 hours per week. John Froelich moved to allow the part-time staff in Corrections to go over the 19 hours per week and become eligible for benefits, as required; Mike Metcalf seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". Sheriff McClaflin discussed home monitoring as part of the work release program. Mike Metcalf moved to approve signing the home-monitoring contract, with the cost being passed onto the inmate as part of their work-release fee; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".

<u>Auditor – Minutes</u>

Mike Metcalf moved to approve the July 17, 2018 minutes; John Froelich seconded the motion. Motion carried.

<u>Social Services – Budget Update</u>

Wanda Larson, Social Services Director, presented an updated 2019 budget request reflecting a \$43,360 deficit, which, if approved, would add an additional $\frac{1}{2}$ mill to the General Fund 2019 budget.

VC-BC Development Corporation – Litchville Building Demolition & Workforce Development

Jennifer Feist, Director of Development, Valley City – Barnes County Development Corporation, requested \$1,000 from the Barnes County Economic Development Fund to assist the Litchville Community Development Corporation with funding to demolish a building located on Main Street, which is a safety hazard. Mark Formo presented pictures supporting the need for demolition. Mike Metcalf moved to approve the request; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". Ms. Feist then requested \$25,000 for workforce development to assist with equipment purchases and training at the Sheyenne Valley Career & Technology Center. Mike Metcalf moved to approve the request, contingent upon all the other funding pieces falling into place; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".

Budget Discussion

Cindy Schwehr made a motion to approve the preliminary 2019 County budget for publication at 103.38 mills; Mike Metcalf seconded the motion. Cindy Schwehr rescinded her motion; Mike Metcalf rescinded his second. Cindy Schwehr made a motion to approve the preliminary 2019 County budget for publication at 104 mills; Mike Metcalf seconded the motion. Motion carried upon roll-call vote, with Rodger Berntson voting "no". The 2019 budget hearing will be held on September 18, 2018 at 6:00 p.m. in the Barnes County Commission chambers.

Commission Discussion

Commission discussion included construction beginning on the airport wildlife fence, County park board meeting this Thursday, Employee Policy committee meeting requested, and Senator Heidi Heitkamp's recent visit to Valley City. The Commission also reminds department heads to bring their new employees to a Commission meeting to introduce them as soon as possible after hiring.
