

The Barnes County Commission met in regular session on Tuesday, January 5, 2021 with Cindy Schwehr, Vicky Lovell, Bill Carlblom, Pete Paulson, and Shawn Olauson present. Chairman Carlblom called the meeting to order at 8:00 a.m., the Pledge of Allegiance was recited, and the Agenda was reviewed.

VC-BC Development Corporation – Contract / Requests for Funds / Joint Powers Agreement

Cindy Schwehr moved to sign the Agreement between the Valley City – Barnes County Development Corporation and Barnes County; Shawn Olauson seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

Jennifer Feist, Valley City – Barnes County Development Corporation Director of Development, requested approval of \$22,040 for membership in the South Central Dakota Regional Council funded through the mill levy for economic development. Shawn Olauson moved to approve the request and sign the Joint Powers Agreement; Vicky Lovell seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

Ms. Feist requested approval of \$70,000 from the Barnes County Economic Development Fund to support the ND National Guard (land and infrastructure) in the I-94 Regional Development Corridor. Cindy Schwehr moved to approve the request; Bill Carlblom seconded the motion. Motion carried upon roll-call vote, with Vicky Lovell voting “no”.

Planning & Zoning - Variance

Jessica Jenrich, Planning & Zoning Coordinator, presented an application for a Variance – Structure Setback from Trevor Jacobsen (Baldwin Township, 21-143-57). Vicky Lovell moved to have Mr. Jacobsen move the bin by August 1, 2021, and to waive all fees, as long as the bin is moved by that date; Shawn Olauson seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

Dispatch – Vacation Time

Holly Neuberger, Dispatch Coordinator, requested a one or two-month extension for two employees to spend down some of their vacation, due to not being able to take time off in the last few months, as Dispatch was short-staffed due to covid-19. Cindy Schwehr moved to deny the requests; Vicky Lovell seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.
