

The Barnes County Commission met in regular session on Tuesday, May 18, 2021 with Cindy Schwehr, Vicky Lovell, Pete Paulson, and Shawn Olauson present. Bill Carlblom attended via phone. Vice-Chairman Schwehr called the meeting to order at 8:00 a.m., the Pledge of Allegiance was recited, and the Agenda was reviewed.

**MIS – Panic Buttons / Phone System**

Jason Thiel, MIS Director, presented a proposal for a courthouse panic button system upgrade, with a cost of \$600 for the upgrade and a monthly monitoring fee of \$34.95. Shawn Olauson moved to approve the proposal; Bill Carlblom seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”. Mr. Thiel presented a proposal to upgrade our current phone system at a cost of \$5,648.00. Vicky Lovell moved to approve the proposal; Shawn Olauson seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

**Planning & Zoning - Variances**

Jessica Jenrich, Planning & Zoning Coordinator, presented an application for a Variance from Dickey Rural Telephone Cooperative (Springvale Township, Sections 13, 14, 15, 16 & 17). Shawn Olauson moved to approve the application; Vicky Lovell seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”. Ms. Jenrich presented an application for a Variance - Setback from BEK Communications (Ellsbury Township, SW ¼ Section 33). Pete Paulson moved to approve the application; Vicky Lovell seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

**Sheyenne River Valley Chapter of North Country Trail Association - Easement**

Bobby Koeplin appeared representing the Sheyenne River Valley Chapter of the North Country Trail Association and requested approval of an Easement & Maintenance Agreement for a re-route of the Martin’s Landing segment of the North Country Trail, due to land slumping that has occurred. Cindy Schwehr moved to approve the request, contingent upon State’s Attorney review; Bill Carlblom seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

**AP – Construction Update**

Madison Young, Brian Kunz, and Ryan Weber, Adolfson Peterson Construction, provided construction updates for the Correctional Center. Construction is 75% complete, in good shape and still on schedule.

**Auditor – Minutes**

Shawn Olauson moved to approve the May 4, 2021 minutes; Bill Carlblom seconded the motion. Motion carried.

**Highway Dept – Construction Engineering Selection / Project Updates**

Kerry Johnson, Highway Superintendent, and Jamie Smith, Highway Admin Asst, presented the bid letting results for the box culvert (low bid from Gladen Construction of \$285,933) and the County Road #11 grade raise (low bid from Border States of \$1,626,743). Pete Paulson moved to approve the resolutions to accept both bids; Shawn Olauson seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.
