

BARNES COUNTY ELECTION PRECINCTS

#1 - Valley City, City Hall: Bordered on the south from the intersection of 6th Street NE and 2nd Avenue NE easterly along 6th Street NE to the Hospital Bridge; thence southeasterly from the hospital bridge along 9th Avenue NE to its intersection with 5th Street NE; thence easterly along 5th Street NE to its intersection with 12th Avenue NE extending easterly from said point to the Corporate limits. Bordered on the west from the intersection of 6th Street NE and 2nd Avenue NE northerly along 2nd Avenue NE to 9th Street NE; thence west along 9th Street NE to Central Avenue north; thence north along Central Avenue to 12th Street NE, thence East along 12th Street NE to 5th Avenue NE; thence north along 5th Avenue NE to the Corporate limits. Bordered on the north by the Corporate limits. Bordered on the east by the Corporate limits.

#2 - Valley City Police Station/Municipal Court Room: Bordered the north from the intersection of 6th Street NE and 2nd Avenue NE easterly along 6th Street NE to the Hospital Bridge; thence southeasterly from the Hospital Bridge along 9th Avenue NE to its Intersection with 5th Street NE; thence easterly along 5th Street NE to its intersection with 12th Avenue NE extending easterly from said point to the Corporate limits. Bordered on the west from the intersection of 6th Street NE and 2nd Avenue NE southerly along 2nd Avenue NE to its intersection with Main Street east; thence continuing southerly along 2nd Avenue SE to its intersection with 4th Street SE; extending southerly from said point to the Corporate limits. Bordered on the south by the Corporate limits. Bordered on the east by the Corporate limits.

#3 - Skoal Room VCSU Student Center VC: Bordered on the east from the intersection of Main Street east and 2nd Avenue SE; thence southerly along 2nd Avenue SE to its intersection with 4th Street SE; extending southerly from said point to the Corporate limits. Bordered on the north from the intersection of Main Street east and 2nd Avenue SE; thence westerly along Main Street to its intersection with 8th Avenue SW. Bordered on the west from the intersection of Main Street west and 8th Avenue SW; thence south along 8th Avenue SW Approximately seven blocks to the Sheyenne River; thence southwesterly along the west bank of the Sheyenne River to the Corporate limits. Bordered on the south by the Corporate limits.

#4 - WE Osmon Field House VC: Bordered on the north from the intersection of 2nd Avenue NE and 5th Street NE west along 5th Street NE and 5th Street NW to the Corporate Limits. Bordered on the East from the Intersection of 5th Street NE and 2nd Avenue NE, thence South to Main Street East. Bordered on the south from the intersection of Main Street east and 2nd Avenue NE west along Main Street to its intersection with 8th Avenue SW Bordered on the east from the intersection of Main Street west and 8th Avenue SW; thence south along 8th Avenue SW approximately seven blocks to the Sheyenne River; thence southwesterly along the west bank of the Sheyenne River to the Corporate limits. Bordered on the west and south by the Corporate limits.

#5 - Sheyenne Care Center VC: Bordered on the south from the intersection of 2nd Avenue NE and 5th Street NE west along 5th Street NE and continuing west along 5th Street NW to the Corporate limits. Bordered on the east from the intersection of 5th Street NE and 2nd Avenue NE northerly along 2nd Avenue NE to 9th Street NE; thence west along 9th Street NE to Central Avenue north; thence north along Central Avenue north to 12th Street NE; thence east along 12th Street NE to 5th Avenue NE; thence north along 5th Avenue to the Corporate limits. Bordered on the north by the Corporate limits. Bordered on the west by the Corporate limits.

#6 - Sod Buster Club: The Cities of Sibley, Dazey, Rogers, and Pillsbury and the Townships of Sibley Trail, Dazey, Rogers, Ellsbury, Baldwin, Grand Prairie, and Ashtabula

#7 - Wimbledon Community Hall: City of Wimbledon and the Townships of Pierce and Lake Town

#8 - Edna Fire Hall: City of Leal and the Townships of Edna, Brimer, Uxbridge, and Anderson

#9 - Sanborn Community Center: City of Sanborn and the Townships of Potter, Eckelson, Mansfield, Meadow Lake, and Hemen

#10 - Barnes County Highway Department: The Townships of Stewart and Getchell

#11 - Barnes County Court House: The Townships of Valley, Hobart, Green, and Marsh

#12 - Oriska School : City of Oriska and the Townships of Oriska, Minnie Lake, Weimer, Noltimier, and Alta
