We're having problems with our card reader system in gift shop. There is much confusion. Ticket sales have been done over the phone. Wes has done all of them. Two have come back as returns of \$125 dollars. There has been a problem with a sale as well. It doesn't seem to be consistent.

In July, a representative from Dacotah Bank did reprogram the machine to change the vendor numbers on the machine from #1 Museum and #2 Gift Shop to #1 Gift Shop and #2 Museum to make it easier for volunteers to remember. New information learned today is nolonger #1 to "wake the machine up" and then #2 is refund. Something doesn't make sense with this.

We have changed credit card management systems away from Dacotah Bank and to Payprotec. We're not entirely certain how it happened. We believed we were working with our Dacotah Bank but had been charged 114% per sale. The machine we're currently using that we purchased we're told is obsolete. In an attempt to change categories from Corporate rate to smaller charge a change was inadvertently made. We're now under contract to payprotec for a year. That account has not been set up yet. Two new reader machines are here. Have we been headhunted? Have we been scammed? Is there a way to back out of the contract as it was not board approved.
