The meeting was called to order at 10:00AM by DuWayne.

Minutes were presented by DuWayne from the previous meeting of April 10th 2018. No noted changes and were approved.

Sue provided a brief Treasurer's Report indicating there is a balance of roughly \$11,000

Old Business:

- ◆ Gary thanked the LEPC committee for the monetary donation to the VCFD for the State Fire Convention
- ◆ DuWayne mentioned that the Sanborn First Responders are now NARCAN trained— BCN School is equipped.

New Business:

- ◆ Wes Anderson was present for the meeting and asked about getting the Barnes County Museum into the Barnes County Hazard Mitigation Plan. Sue informed the committee that the plan was done in 2015, and is updated every 5 years so it will not be revised until 2020. Wes acknowledged this and indicated he just needed to ask to be put in the plan when it is updated.
- ◆ Sue provided an update on Tier II Reports, she is waiting on a couple of reports that the state had received that were not sent to her, once she gets the missing ones from the state she will send out the updated list to all members and also post it on the Barnes County Website.
- ◆ Casey Skramstad, from the Open Door Center in Valley City, was present and indicated that the Open Door Center is interested in doing an exercise of some sort. Frank and Sue will work with the Open Door Center to figure out what type of exercise/drill would work. Frank indicated that doing the same type of exercise that Anne Carlsen conducted would be a good idea. Sue and Frank will connect with Mary Simonsen from the Open Door to coordinate.
- ◆ DuWayne informed the committee that there is going to be Anhydrous Response Training put on by on July 19th, 2018 at 6:00 pm down by the Litchville Site.
- ◆ DuWayne also informed the committee of Management Training being put on by the ND EMS association
- ◆ Frank stated that the new radios SIREN 20/20 is still being worked on and he had no new information to offer.
- ◆ DuWayne adjourned the meeting at 10:30AM
