# MINUTES - SEPTEMBER 9, 2010

Chairman Eldred Knutson opened the meeting.

Bob Nelson met with the Board to discuss vehicles he has parked near the Oakes interchange on his private road. Mr. Nelson assured the Board that he has moved the cars behind his trees and his camper will be moved when he makes room.
