Minutes – October 10, 2023

Meeting called to order by Vice Chairman Bill Carlblom at 6:00 p.m.

Motion by Bishop, 2nd by Bopp to approve the September 12, 2023 minutes. Motion carried.

Meeting recessed for Brad Knutson for a Structure Setback Variance for 120' from the center of the township road 117th Ave SE. Mr. Knutson was present to answer any questions. No one appeared to protest. Carlblom reopened the meeting for discussion. Motion by Bishop, seconded by Roorda to approve the Variance as there is already a building and trees that are closer to the road than 120'. Motion carried upon roll call vote, with all members voting "yes".

Meeting recessed for William Poukka for a Structure Setback Variance of 73' and 110' from the center of the township road 36th St SE. No one appeared to protest. Carlblom reopened the meeting for discussion. Motion by Bishop, seconded by S. Olauson to approve the Variance as that the building that the additions are going on is already the 73' from the center of the road and there are trees closer. Motion carried upon roll call vote, with all members voting "yes".

Meeting recessed for Tim Richman for a Drain Tile Setback Variance of under 75' from the center of the township road 36th St SE. No one appeared to protest. Carlblom reopened the meeting for discussion. Motion by Bishop, seconded Bopp to approve the Variance contingent that there is a signature acquired from Oriska Township and also that the drain tile does not go within the right of way other than where boring under the road. Motion carried upon roll call vote, with all members voting "yes".
