

The August meeting was called to order by Vice Chairman Olson at 10:05am at the District Office in Valley City, ND. Minutes from the July 11th, 2018 board meeting were reviewed, and Vice Chairman Olson declared those minutes approved as emailed.

#### **FINANCIALS:**

A list of receipts and bills paid during July 2018, were reviewed by the Board. Paulson made a motion to accept the July 2018 financial statement as presented with Stenson seconding it. All in favor aye. Motion carried.

The no till drill needs a lot of updating and maintenance. The estimate would be close to \$7,500. Jason would be doing the work. Nelson made a motion to proceed with the updating/maintenance, Paulson second the motion. All in favor aye, motion carried. OHF – there is money left to put in a canoe launch at the Riparian Park, Jason has been in contact with Andrea - Industrial Committee.. In order to use the money towards the launch, there has to be an amendment to our grant. Jason would present on Aug. 20<sup>th</sup> for the amendment. He would also reach out to other sponsors of the Riparian Park to donate monies towards the cost share of the canoe launch as well as purchase 2 picnic tables. The board granted permission to do the amendment and continue with the project. Stenson made a motion to purchase the tables, Paulson second the motion. All in favor aye, motion carried.

#### **PROGRAMS:**

# EQIP:

- Taking applications for FY 2019.
  - o Currently meeting with producers on their land to go over their resource concerns.
- Going on site to certify practices have been completed.

# **EQIP- Red River Basin Initiative (RRBI):**

1 application preapproved for funding- The applicant decided to cancel on Monday.

#### CSP:

- Following up with producers on enhancements that are to be completing in 2018.
- Done field verifying 2 CSP renewal contracts, need to start working on the next steps because CAET's are due in early September.

#### CRP:

- FSA is accepting Continuous CRP Sign-up 51 offers from June 4<sup>th</sup> to August 17<sup>th</sup>, 2018.
  - Ask Barb for more info.
- CRP- 1-year Contract Extension sign up is from June 4<sup>th</sup> to August 17<sup>th</sup>, 2018.
  - o CRP contract cannot exceed 15 years.
- FSA announced CRP Grassland Signup 201 for landowners to protect pastureland and rangeland, while maintaining those areas as grazing lands. Sign up until August 17th, 2018.

#### WRE:

- Annual Monitoring Worksheets (On-site reviews) were due August 1<sup>st</sup>. All have been completed.
- Working on Compatible Use Authorization (CUA) forms for contract holders who want to clip and hay their easements in 2018 (only fields that weren't clipped last year for emergency drought are eligible to be clipped this year).

### Water Bank Program:

- o 1 application that ranked high enough to obtain more information.
  - That application has been approved for funding if producer wants to continue.

#### Other:

Salinity Plot:

 Need to run the Electrical Conductivity (EC) for the soil samples we took this spring, now that they are dry.

 Going to get out onsite again this week and check on cover crop species. Was out there a few weeks ago and things were looking o.k.

Working on a Salinity Plot Field Tour- it is Thursday, September 20<sup>th</sup>, from 10 a.m. to 1 p.m. See the draft flyer.

# Tree Cooler-

- Contacted Corp of Eng. and Water Board. They do not require any permit to put in launch. As long as river edge and channel are not manipulated.

#### **OHF Trees-**

- Contacted 16 producers that expressed interest in cost share on tree plantings
- Only 1 went forward with filling out tree plan and application
