

The Barnes County Commission met in regular session on Tuesday, August 1, 2017 with Cindy Schwehr, Bill Carlblom, Mike Metcalf, John Froelich, and Rodger Berntson present. Chairman Metcalf called the meeting to order at 8:00 a.m., the Pledge of Allegiance was recited, and the Agenda was reviewed.

**Sheriff – Old Records / Former National Guard Lot at Airport / Upcoming Events**

Randy McClaflin, Sheriff, informed the Commission that the State Historical Society would like our old jail records. Rodger Berntson moved that the books are County property and should remain as such; Bill Carlblom seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

Sheriff McClaflin and Barnes County Municipal Airport manager Mike Lerud visited with the Commission regarding the Sheriff's Department renting the former National Guard buildings and lot at the airport, which would replace the current storage situation. The Airport is proposing a rent figure high enough to cover the taxes on the T-Hanger.
