John Froelich moved to approve the following resolution, to be presented at the North Dakota Association of Counties Convention in October: The North Dakota Department of Transportation Safety Committee will recommend that all walkers, runners, and bicyclists should wear a reflective vest; Bill Carlblom seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".

Sheriff / Dispatch - Responding to Calls on Interstate

Sheriff Randy McClaflin, Sue Lloyd, Emergency Manager / Dispatch Coordinator, and Holly Neuberger, Assistant Dispatch Coordinator visited with the Commission regarding confusion as to whether and when State Radio and Highway Patrol are being called out to respond to non-accident calls. Sheriff McClaflin will contact State Radio to clarify the procedure.

Social Services – Salary Request

Wanda Larson, Social Services Director, requested approval to offer new Eligibility Worker Tina Sakett a salary of \$3,000 a month. Cindy Schwehr moved to approve the request; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".

<u> Auditor – Minutes</u>

Bill Carlblom moved to approve the August 15, 2017 minutes; Rodger Berntson seconded the motion. Motion carried.

Auditor – Special Event Permit Applications

Bill Carlblom moved to approve an Application for Special Permit to Sell Alcoholic Beverages at a Special Event at Designated Premises from the Valley City Eagles Aerie 2192 for a wedding reception on 9/16/2017 at Riverbend Farm; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".

Cindy Schwehr moved to approve an Application for Special Permit to Sell Alcoholic Beverages at a Special Event at Designated Premises from Red Trail Vineyard for a Farm to Table Event on 9/11/2017 at Riverbend Farm; Bill Carlblom seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".

Commission Discussion

Costco has asked for permission to solicit Barnes County employees; the Commission said "thanks, but no thanks". This goes against current County policy.

The Commission agreed that we need to keep the annual leasing of the FEMA properties in the fall, and not allow leasing outside of this time-frame. The Commission has the right to make exemptions for driving on the property to get to the lakefront.

Cindy Schwehr moved to sign the Final Certification for the railroad gate project near Barnes County North; Bill Carlblom seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".

Rodger Berntson moved to sign the Final Certification for the North Valley railroad crossing project; Bill Carlblom seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".

2018 Budget Discussion

Rodger Berntson moved to increase the County Share of health insurance from 75% to 80%, with no across-theboard increases, and including increases for specific employees as indicated in the payroll budget scenarios, as well as Social Services, as presented; Cindy Schwehr seconded the motion. Motion failed upon roll-call vote, with John Froelich, Mike Metcalf, Cindy Schwehr and Bill Carlblom voting "no".

Cindy Schwehr moved to increase the County Share of health insurance from 75% to 80%, with a 1% across-theboard salary increase, and increases for specific employees as indicated in the payroll budget scenarios, as well as Social Services, as presented; Rodger Berntson seconded the motion. Motion carried upon roll-call vote, with Rodger Berntson and Bill Carlblom voting "no".

John Froelich moved to approve the budget proposal for publication, as presented, with the exception of increasing Farm to Market from 10 mills to 11 mills, resulting in total mills for publication of 98.24 mills; Bill Carlblom seconded

the motion. Motion carried upon roll-call vote, with Rodger Berntson voting "no".
