The Barnes County Commission met in regular session on Tuesday, October 3, 2017 with Cindy Schwehr, Bill Carlblom, Mike Metcalf, John Froelich, and Rodger Berntson present. Chairman Metcalf called the meeting to order at 8:00 a.m., the Pledge of Allegiance was recited, and the Agenda was reviewed.

County-Owned Property Lease-Letting

Cindy Schwehr moved to set the lease term at five years, unless the lessee breaks the contract; Bill Carlblom seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". The County had a number of FEMA and non-FEMA properties available for leasing. Eldred Knutson bid \$50 on Parcel #20-0940430. Dan Fairfield bid \$50 on Parcel #23-2210120. No other interested parties appeared to bid on the lease properties, and Mike Metcalf declared the bids accepted and the bidding process "closed".

Highway Department - Dreis' Bridge / County Rd #21 Erosion

Kerry Johnson, Highway Superintendent, provided an update on the Dreis' Bridge project in Dazey Township. John Froelich made a motion to proceed with the repair on the County Road #21 erosion site, with the County Share being \$80,327; Rodger Berntson seconded the motion. Motion carried upon roll-call vote, with all members voting "ves".

Highway Department - Litchville DOT Shop

The Commission discussed taking over the State shop in Litchville, and they all agreed to not move forward with that at this time.

Sheriff - Former National Guard Buildings at the Airport

Randy McClaflin, Sheriff, and Chief Deputy Don Fiebiger presented a proposed lease agreement for use of the former National Guard buildings at the Airport at a cost of \$7,200 annually, for a term of three years, starting on November 1st. Bill Carlblom moved to approve the lease; Cindy Schwehr seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". Sheriff McClaflin asked for permission to purchase a radio for the Truck Regulatory vehicle at a cost of \$1,700, as long as there is money left in his budget at the end of the year. Cindy Schwehr moved to approve the request, pending availability of funds; Bill Carlblom seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".

<u> Auditor – Minutes / Appraisal Proposal</u>

Bill Carlblom moved to approve the September 19, 2017 minutes, the September 19, 2017 Budget Hearing minutes, and the September 22, 2017 Special Emergency Meeting minutes; John Froelich seconded the motion. Motion carried. Beth Didier, Auditor, presented a proposal from Valuations Northwest for appraisal services for insurance purposes. Bill Carlblom moved to move forward with the building appraisal at a cost of \$5,130; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".

Appraisal for Annual Tax Deed Property Sale

The Commissioners reviewed the list of properties and set sale prices for each property to be sold at the Annual Tax Deed Sale on Tuesday, November 21, 2017 at 8:00 a.m. A hearing will be held on October 17, 2017 at 6 p.m. for the cities and townships affected to discuss the set sale prices.

2018 Budget Finalization

John Froelich moved to amend the budget so that the 1% across the board raise does not include the County Commissioners; Cindy Schwehr seconded the motion. Motion failed, with Bill Carlblom, Mike Metcalf, and Rodger Berntson voting "no". John Froelich moved to approve the 2018 budget, as presented, with the County levying 98.24 mills; Cindy Schwehr seconded the motion. Motion carried upon roll-call vote, with Rodger Berntson voting "no".

Commission Discussion

Palmer Paulson appeared before the Commission to discuss ditch access and his easement near the Faust Dam Bridge. Cindy Schwehr moved to appoint Dawn Riley and Pete Paulson as Barnes County's North Dakota State Fair delegates to the annual meeting on November 15, 2017; Bill Carlblom seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". The Barnes County Museum will be holding a fundraiser at the Valley City Eagles on October 23, 2017 from 5 – 7 p.m. Other discussion included Hobart Lake, Census 2020, and SCDRC dues structure.
