WHEREAS, the Barnes County Planning Commission has undertaken the task of revising the Barnes County Development Code, to include processes and procedures for the manufacturing and distribution of medical marijuana as well as modification and corrections to other zoning and subdivision regulations including but not limited to zoning district setbacks, regulation of tree plantings, and fines for violations of zoning regulations. WHEREAS, input from the public was sought during the planning process, and WHEREAS, the public was notified of and invited to attend hearings where the changes were reviewed and discussed. WHEREAS, the Development Code changes were duly noticed in the official county paper for two consecutive weeks and a public hearing was held on October 12, 2017, with the Planning Commission, and WHEREAS, the Planning Commission has reviewed and provided their recommendation to the Board of County Commissioners for approval of the revision of the Development Code, WHEREAS, the Development Code is attached hereto with revision, additions and deletions as noted.
