

The Barnes County Commission met in regular session on Tuesday, June 5, 2018 with Cindy Schwehr, Mike Metcalf, Bill Carlbom, John Froelich, and Rodger Berntson present. Chairman Carlbom called the meeting to order at 8:00 a.m., the Pledge of Allegiance was recited, and the Agenda was reviewed.

#### **MIS – Courthouse Camera Grant**

Jason Thiel, MIS Director, informed the Commission that Sue Lloyd, Emergency Manager, secured a grant for \$20,000 to replace the courthouse camera system. Mike Metcalf moved to accept the low bid from Electro Watchman, Inc. of \$26,655.70; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”. \$5,500 was budgeted for this project, and the difference will be made up with cash back from the MIS Department credit card, making this project budget neutral.

#### **Highway Department – Approach Application**

Kerry Johnson, Highway Superintendent, presented an Approach Application from Joel McClean for an approach at 16-138-61. Rodger Berntson moved to approve the application; Mike Metcalf seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

#### **Auditor – Minutes / Special Event Permit – Dakota Riders Hillclimb / Gaming Site Authorization**

Mike Metcalf moved to approve the May 15, 2018 minutes; John Froelich seconded the motion. Motion carried. Mike Metcalf moved to approve an Application for Special Permit to Sell Alcoholic Beverages at a Special Event at Designated Premises from Boomers Corner Keg for the Dakota Riders Hillclimb on Sunday, June 17, 2018; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”. Cindy Schwehr moved to approve a Gaming Site Authorization for Cooperstown Municipal Association at Sodbusters near Sibley; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

#### **Tax Equalization – Sidwell Contract Renewal / Equalization Updates**

Stacie Hansen-Leier, Tax Director, presented the Sidwell Contract for renewal at a cost of \$5,500 annually for two years, effective July 1, 2018. Mike Metcalf moved to approve the contract; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”. Ms. Hansen-Leier then briefed the Commission on the upcoming equalization proceedings.

#### **Commission Discussion**

Cindy Schwehr made a motion to require all staff to wear IDs and that they be uniform and made by the MIS department; John Froelich seconded the motion. Cindy Schwehr moved to rescind the previous motion; John Froelich seconded the motion. Cindy Schwehr made a motion to require all office staff to wear IDs, and that they be uniform and made by the MIS department; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

Water Resources is considering setting up an assessment district for snagging & clearing of the Eckelson Lake outlet; hearing is tentatively scheduled for July 9<sup>th</sup> and three commissioners need to be there. Contractor for Hobart Lake is talking about an extension from June to July; discussion will be next Monday. The County Commission can set a limit on total payment for final disposition (County burials). John Froelich suggested \$2,500 for cremation and \$3,000 for burial. This will be discussed July 3<sup>rd</sup>.

Mike Metcalf moved to recess for lunch; Cindy Schwehr seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

#### **2018 County Equalization Meeting**

Bill Carlbom opened the meeting at 1 pm, and proceeded with the Equalization hearing. Instructions were given. The following recommendations were presented by Ms. Hansen-Leier, and the following requests were made by the property owners:
