John Froelich moved to increase the County Share of health insurance coverage from 80% to 85% and to grant each department 1% of their current salaries, with the Department Head determining how the pool of funds is disbursed within his/her department; Mike Metcalf seconded the motion. Motion carried upon roll-call vote, with Bill Carlblom and Rodger Berntson voting "no". Other discussion included raising the pay grades of seven department heads from Grade 9 to Grade 10; no action was taken at this time.
