Emergency Management – Repeater Tower / 911 Addresses

Sue Lloyd, Emergency Manager / Dispatch Coordinator, presented a letter to be sent out to people whose mailing addresses will be changing, due to correcting of the addresses for the 911 system. John Froelich moved to approve the addressing letter; Cindy Schwehr seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". Rodger Berntson moved to waive the annual rent from Barnes Rural Water on the south tower in exchange for Barnes Rural Water servicing the generator in the south tower; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". A Memorandum of Understanding will be drawn up. Training for Text-to-911 calls will be on December 16, 2018, and Text-to-911 will start being implemented at the end of December.

<u>Highway Department - Bridge Project / Project Updates</u>

Kerry Johnson, Highway Superintendent, and Shawn Mayfield, Kadrmas, Lee & Jackson, provided updates on the upcoming paving projects. Cindy Schwehr moved to approve going forward with a box culvert project to replace an old wooden bridge in Raritan Township; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". Cindy Schwehr moved to put a liner in the culvert on County #38 between State Highway #1 and Litchville at a cost of \$19,300; Rodger Berntson seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".

Social Services - Legislative Letter

Wanda Larson, Social Services Director, presented a letter regarding the Social Service re-design that the Social Services board wishes to send to the legislature, and requested the Commission's approval. Cindy Schwehr moved to approve sending the letter, with some suggested changes; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".

<u>Auditor – Minutes / Detention Services Agreement / Maintenance Certification Form / Mailing Service Request / Litchville Bulletin Request / EAP Contract</u>

John Froelich moved to approve the October 16, 2018 minutes; Cindy Schwehr seconded the motion. Motion carried. Cindy Schwehr moved to approve the Detention Service Agreement with the North Dakota Department of Corrections; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". John Froelich moved to approve the NDDOT Maintenance Certification for County Federal Aid Project; Cindy Schwehr seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". Auditor Beth Didier requested approval to continue using a mailing service for large mailings in the Auditor's and Treasurer's offices, as cost-savings of approximately \$2,000 was demonstrated with the Estimated Tax Statement mailing. Cindy Schwehr moved to approve the request; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". Auditor Didier presented a request from the Litchville Bulletin to print Commission minutes in their newspaper at a reduced rate of \$0.15 per line, and proposed that just the minutes be printed, not including the bill listing, which would significantly reduce the cost while still presenting the important information. Rodger Berntson moved to approve the request for printing the minutes only, effective today, as well as printing the agenda; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". Cindy Schwehr moved to approve the EAP Full Service Contract for Services – Employee Assistance Program with the Village Business Institute; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". Cindy Schwehr moved to approve Application for a Local Permit from Ashtabula Fireworks Association; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".

Commission Discussion

Employee parking was discussed again, questioning whether there are enough accessible parking spaces. The County Christmas Party will be held at the Eagles on December 1st. The Airport's wildlife fence should be complete by the middle of the month. City-County Health has been dealing with several septic-system issues. Cindy Schwehr asked if septic requirements should be added to the Planning & Zoning regulations. There are several board openings that will be advertised: Airport, City-County Health District, Coroner, Housing Authority, Park, Planning & Zoning Districts 2 & 4, School Annexation Districts 3 & 5, School Tuition – Open Member at Large, Water Resources District 4, and Weed Control (2 positions).
