

The Barnes County Commission met in regular session on Tuesday, February 5, 2019 with Cindy Schwehr, Vicky Lovell, Bill Carlblom, John Froelich, and Shawn Olauson present. Chairman Carlblom called the meeting to order at 8:00 a.m., the Pledge of Allegiance was recited, and the Agenda was reviewed.

**Faust Park Maintenance Contract**

Cindy Schwehr moved to approve the Faust Park Management and Maintenance Contract with Barnes County Wildlife; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".

**Social Services – Salary Correction**

Wanda Larson, Social Services Director, presented a salary correction for Carrie Swenson, which was originally miscalculated, going from \$23.07 to \$25.05. John Froelich moved to pay the corrected amount retroactively; Bill Carlblom seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".

**Highway Department – Bid Award: Raritan Box Culvert**

Kerry Johnson, Highway Superintendent, and Shawn Mayfield, Kadmas, Lee & Jackson, presented the results of yesterday's bid opening. Riley Brothers of Morris MN was the low bid for the Raritan Box Culvert project at \$238,932. Mr. Mayfield's estimate was \$314,520. Cindy Schwehr moved to accept the low bid; Vicky Lovell seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". Jamie Smith achieved Level I Road Scholar at the 2019 North Dakota County Engineers Association Conference and Tim Tangen achieved Level II Road Scholar.

**Commission Discussion**
