

The Barnes County Commission met in regular session on Tuesday, April 2, 2019 with Cindy Schwehr, Vicky Lovell, Bill Carlbom, John Froelich, and Shawn Olauson present. Chairman Carlbom called the meeting to order at 8:00 a.m., the Pledge of Allegiance was recited, and the Agenda was reviewed.

Planning & Zoning - Variance

Jessica Jenrich, Planning & Zoning Coordinator, presented an application for a Variance - Setback from Barnes County Soil Conservation District (Marsh Township, Lots C & D Eggerts Acres in the NE ¼ of 16-139-58). John Froelich moved to approve the application; Shawn Olauson seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

Sheriff/Corrections – Jail Door Locks / Car Repeater

Sheriff Randy McClafin updated the Commission on the Statewide Interoperable Radio Network (SIRN) funding through the State. John Froelich moved to add in-out reader to booking door and secure visitor room doors per the quote from Electro Watchman, Inc. in the amount of \$6,394.35; Cindy Schwehr seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”. Sheriff McClafin asked the Commission to consider 4-wheel drives or larger SUVs when bidding future vehicle replacements, as well as dual batteries.

Emergency Management – Flood Update / Emergency Declaration

Sue Lloyd, Emergency Manager, and Dave Schelkopf, Valley City City Administrator, provided an update on potential flooding. River is almost ice-free, so the Corps of Engineers will be upping the outflow to 1,200 cfs. There are no County roads closed, but there are some township roads with issues. Ms. Lloyd asked that the Commission consider declaring an emergency, so that the County could access emergency funds, if needed, and that the County and Valley City work out of the same sandbag location. Vicky Lovell moved to declare an Emergency and approved working with the City and the North Dakota Winter Show on a joint sandbag effort; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

**BARNES COUNTY COMMISSION RESOLUTION 2019-1
A RESOLUTION FOR DECLARATION OF A FLOOD EMERGENCY**

WHEREAS, the County of Barnes has the potential for severe spring flooding due to spring thaw, accompanied by potential additional precipitation; and WHEREAS, Governor Doug Burgum has already, by Executive Order 2019-03, declared a statewide flood emergency in the State of North Dakota; and WHEREAS, the impact of this thaw, runoff, and precipitation threatens the health, well-being and public safety of the citizens of Barnes County; and WHEREAS, necessary mitigation measures, preparedness actions, and other responses must begin immediately to protect public health and safety; and WHEREAS, the potential damage to public and private property in addition to County, Township, and City roads is beyond normal anticipated and budgeted funds; and WHEREAS, the cost of cleanup, repair and replacement of such damaged facilities is far in excess of County, Township, and City resources.

NOW, THEREFORE, BE IT RESOLVED that the Board of Commissioners of the County of Barnes, declares an emergency and orders the activation and utilization of the Barnes County Emergency Operations Plan, its procedures, attachments and appendices to recover from the situation, develop a detailed damage assessment, reduce hardship and initiate the appropriate relief actions and mitigation measures by departments and agencies of local government to limit the hardships and impacts of this emergency upon the citizens of Barnes County.
