

The Barnes County Commission met in regular session on Tuesday, November 5, 2019 with Cindy Schwehr, Vicky Lovell, Bill Carlblom, John Froelich, and Shawn Olauson present. Chairman Carlblom called the meeting to order at 8:00 a.m., the Pledge of Allegiance was recited, and the Agenda was reviewed.

Jail Committee – CMAR Recommendations

Scott Fettig and Ryan Weber, Klein McCarthy Architects, discussed the process for moving forward with the short-list for Construction Manager at Risk (CMAR) interview and selection process. The interviews will be held on Thursday, November 21, 2019, with a committee update at 4:30 pm and interviews starting at 5:00 pm at ½ hour intervals.

Dispatch – Coordinator / Staffing

John Froelich informed the Commission that Holly Neuberger graduated from Trial Period status as Dispatch Coordinator and moved to give her an additional \$1.50 per hour retroactive to October 16, 2019; Bill Carlblom seconded the motion. Motion carried upon roll-call vote, with Vicky Lovell voting “no”. Holly Neuberger, Dispatch Coordinator, proposed some staffing/management changes. No action was taken, and it will be brought up to the next meeting.

MIS – Sheriff’s Equipment Replacement

Jason Thiel, MIS, presented a request for equipment from CGI to meet the encryption standard, as a result of a recent Criminal Justice Information (CJI) audit, at a cost of \$7,514. Cindy Schwehr moved to approve the request; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

Water Resources – Snagging & Clearing

Shawn Olauson moved to approve Barnes County’s local cost share \$50,250 for the 2019 Sheyenne River Snagging & Clearing – Reach 1 – Project 2; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

Auditor – Minutes / State Fair Delegate

John Froelich moved to approve the October 15, 2019 minutes; Vicky Lovell seconded the motion. Motion carried. Vicky Lovell moved to appoint Randy Grueneich and the President of the ND Winter Show board as State Fair delegates each year to attend the annual meeting of the State Fair Association’s Annual Meeting; Cindy Schwehr seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

Social Services – Zone Addendum

Wanda Larson, Social Services Director, and Tom Overn, Social Services Board President, presented the Human Service Zone Agreement Addendum I. Cindy Schwehr moved to approve the Addendum; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

Extension – NDSU East District Director Introduction

Randy Grueneich, Barnes County NDSU Extension Agent, and Kim Ruliffson, District Director for the East, updated the Commission on the status of the County’s partnership with NDSU Extension, in which NDSU pays 50% of the salaries and all fringe benefits and Barnes County pays the other 50% of salaries.

State’s Attorney – Civil Asset Forfeiture

Tonya Duffy, State’s Attorney, presented a Barnes County Asset Forfeiture Fund and Procedure Policy for the purpose of receiving any forfeited property or proceeds from the sale of forfeited property which has been forfeited to Barnes County by order of the court as a result of the Civil Action process as outlined in N.D.C.C. Section 19-03.1-36.2. No action was taken, and it will be brought up to the next meeting.

Commission Discussion

East Central Commissioners Association members have been contacted. John Froelich moved to disband and divide the money equally between the counties involved; Cindy Schwehr seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”. The Commission discussed agendas for meetings of entities that receive County funding, and that all agendas and minutes should be routed through the County Auditor’s office for distribution. Barnes County Township Officer’s Association meeting will be held on November 21st. Sanborn is dedicating a site for a Veteran’s Park today.
