

The Barnes County Commission met in regular session on Tuesday, March 3, 2020 with Cindy Schwehr, Vicky Lovell, Bill Carlblom, John Froelich, and Shawn Olauson present. Chairman Carlblom called the meeting to order at 8:00 a.m., the Pledge of Allegiance was recited, and the Agenda was reviewed.

Wellness Committee Update

Debbie Magnuson, Randy McClaflin, Theresa Will, Sue Milender, Kerry Johnson, Julie Mindt, and Linda McKenna – Barnes County Wellness Committee members, provided an update on the benefits of County participation in the Wellness Programming and asked for support of a possible future event. The Commission asked that they come back with some ideas. Kerry Johnson presented the traveling trophy for winning the Walking Challenge to the “Smooth Snailing” team, members: Debbie Magnuson, Lori Marshall, Linda McKenna, Julie Mindt, and Jason Thiel.

Jail Financing Options

Mike Manstrom, Dougherty Markets, presented financing options for the proposed jail, discussed current interest rates, and answered questions.

Compensation & Classification Study Options & Cost Estimate

The Commission discussed a proposal from Gallagher Consulting for a compensation and classification study and cost estimate and requested that we have them appear via phone at an upcoming meeting to answer questions.

Department Head Salary Review

John Froelich moved to increase the pay for the Tax Director by \$1 per hour, increase the pay for the Building & Grounds Supervisor by \$1.50 per hour, increase the pay for the Planning & Zoning Coordinator by \$1 per hour, and increase the pay for the Veteran Service Officer by \$2 per hour, effective with the next pay period; Motion failed for lack of a second.

Auditor – Minutes

John Froelich moved to approve the February 18, 2020 minutes; Vicky Lovell seconded the motion. Motion carried.

2020 Election

John Froelich, District 5 Commissioner, announced that he will not be running for re-election as District 5 Commissioner, and encouraged anyone interested in running to submit a petition.

VC-BC Development Corporation

Jennifer Feist, Valley City – Barnes County Development Corporation Director of Development, requested \$50,000 for year 5 (of 5 years) for Gaukler Family Health, Wellness & Physical Education Center. John Froelich moved to approve the request; Cindy Schwehr seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”. Tyler Jacobson, Valley City Parks & Recreation Director, was also present to answer questions.

Ms. Feist requested \$22,040 for membership in the South Central Dakota Regional Council. John Froelich moved to approve the request; Shawn Olauson seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”. Margie Johnson, SCDRC Executive Director, was present to answer questions.

Ms. Feist requested \$70,000 from Barnes County Economic Development Mill Levy Fund to support infrastructure developed for the ND National Guard in the I-94 Regional Development Corridor, for which annual requests are required. This request is year 6 (of 15 years). John Froelich moved to approve the request; Cindy Schwehr seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

Ms. Feist requested up to \$5,000 as a grant to assist with building renovations for the Rusty Spur in Litchville funded through the Barnes County Mill Levy dedicated to Economic Development. Cindy Schwehr moved to approve the request; Vicky Lovell seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

New Employee Introductions

Randy McClaflin introduced Nathan Morten as a new Sheriff’s Deputy. Jason Thiel, MIS Director, introduced MIS Assistant Gage Hilborn.

Highway Dept – Construction Engineering Selection

Kerry Johnson, Highway Superintendent, and Jamie Smith, Highway Admin, discussed road restrictions and presented a recommendation from the interview committee for the Hobart Grade Raise to select Interstate Engineering. Vicky Lovell moved to follow the recommendation and select Interstate Engineering for the Hobart Grade Raise on County Highway #22; Bill Carlblom seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”. Requests for Proposals (design) were sent out for the Emergency Repair sites (riverbank erosion and hill slide, both on the Kathryn Road County Highway #21); six firms responded. They will be doing interviews next Thursday and will come back with a recommendation at the next meeting.

Sue Lloyd – Flood Preparations

Sue Lloyd, Emergency Manager, discussed flood preparations with the Commission. The County will provide empty sandbags, but, at this point, residents will be required to provide their own sand.

Commission Discussion

County Government Week will be planned for April 20-24 with walking tacos on the 21st. Discussion included upcoming meetings, Social Services update, City-County Health elevator repair, Corona Virus preparations, and flood preparedness.
