Shawn Olauson moved to pay \$400,000 of their funds to City County Health District for transfer to their new checking account; Vicky Lovell seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".

Highway Department - Acceptance / Paving Engineering / Project Updates

Cindy Schwehr moved to sign the Acceptance of the Hillslide project; Shawn Olauson seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". Vicky Lovell moved to go forward with the paving project contract for engineering; Pete Paulson seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". Kerry Johnson, Highway Superintendent, provided project updates.
