

The Barnes County Commission met in regular session on Tuesday, November 7, 2023 with Cindy Schwehr, Vicky Lovell, Bill Carlblom, Pete Paulson, and Shawn Olauson present. Chairman Carlblom called the meeting to order at 8:00 a.m., roll-call was taken, the Pledge of Allegiance was recited, and the Agenda was reviewed.

Swearing in of Interim Auditor

Auditor Beth Didier swore in Julie Mindt as Interim Auditor.

VC Schools Building Levy Error Update

Bill Carlblom explained the solution to the Valley City School District Building Levy error. The overtaxed amount for tax years 2019, 2020, 2021 and 2022 will be refunded by the County, with coverage of costs (envelopes, checks, paper, postage, time and 1099s) to be determined between the school board and the Commission. Pete Paulson moved to authorize the plan and move forward; Cindy Schwehr seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".

Highway Dept – LoadPass Permit System / Viking Drive Bridge

Jamie Smith, Road Superintendent, and Tim Tangen, Road Foreman, as well as Joelle VanderLinden from Western Dakota Energy Association, presented information on LoadPass Permits for permit fees. Cindy Schwehr moved to implement the LoadPass permit system, effective January 1, 2024, with an initial set-up cost of \$1,500 and annual cost up to \$500; Shawn Olauson seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". Brian Tykwinski, Kadrmass, Lee & Jackson, updated the Commission on Viking Drive Bridge rehabilitation and other projects. Cindy Schwehr made a motion to move forward with complete replacement of the Viking Drive Bridge; Pete Paulson seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".

Weed Board - Building

Jamen Windish, Weed Officer, provided an update on the building project. Shawn Olauson moved to purchase a blueprint for the building; Pete Paulson seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".

Auditor – Minutes / Post-employment Agreement

Cindy Schwehr moved to approve the October 17, 2023 minutes; Shawn Olauson seconded the motion. Motion carried. Cindy Schwehr moved to approve the Post-employment Agreement with Beth Didier, as presented; Shawn Olauson seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".

Corrections – Medical Bill

Jeremy Wolff, Chief Correctional Officer, informed the Commission of a medical bill for surgery for an inmate at the Correctional Facility in the amount of \$25,000 that the County is responsible for.

Emergency Management – Radios / Exercise Update / NWS Storm Ready

Jessica Jenrich, Emergency Manager, presented a quote for portable radios from Motorola Solutions in the amount of \$13,741.48. Cindy Schwehr moved to approve purchase of the radios, with funding contingent upon inability to find other funding sources; Shawn Olauson seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". The Active Shooter Exercise went well; Ms Jenrich is wrapping up the final reports. James Kaiser, National Weather Service, commended Jessica Jenrich and Barnes County on achieving Storm Ready program status to deal with storms as they come along.

Environmental Services – Boiler System

Shane Kalbrener, Head of Environmental Services, requested approval of cost study for replacement of the Courthouse boiler system, with a cost of up to \$25,000. Cindy Schwehr moved to approve the request; Shawn Olauson seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".

Corrections – Updated Correctional Officer Job Description

Jeremy Wolff, Chief Correctional Officer, presented an updated correctional officer job description for approval. Shawn Olauson moved to approve the document; Cindy Schwehr seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". Bill Carlblom moved to apply \$1 an hour weekend differential for Corrections; Cindy Schwehr seconded the motion. Motion carried upon roll-call vote, with Vicky Lovell voting "no".

Commission Discussion

Commission discussion included portfolio updates. A gesture in memory of Stan Horst was discussed. The Commissioners presented Auditor Didier with a gift in recognition of her 21 years of service to Barnes County.
